The Station will conduct the WTPA's "PA Horse World Expo Website Register To Win Ticket Giveaway - February 21-23, 2025" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.
